As noted in the STORE 2024 Manual and SEER Manual, valid values are based on year of diagnosis. Pay close attention to these specific instructions.

2024: For cases diagnosed January 1, 2024 and forward, The site-specific surgery codes are taken from Appendix C of the 2024 SEER Program Coding and Staging Manual, which is based on Appendix A of the ACoS STORE Manual -revised 2024. The surgery codes are identical to STORE but the SEER appendix also contains supplementary annotations, including coding guidelines, solid tumor rules, EOD schemas, and additional instructions including site-specific codes for Neoadjuvant Therapy Treatment Effect.  - RX Hosp- and RX Summ-Recon Breast: CoC added two new data items, RX Hosp-Recon Breast [751] and RX Summ-Recon Breast [1335] for cases diagnosed on or after January 1, 2024. For diagnosis years 2022 and 2023, CoC collected these data in RX Hosp-Recon Breast [10106] and RX Summ-Recon Breast [10107].
